PRIMARY HEALTH:

NATIONAL

- » Free doctors visits and prescriptions to children under 13 (\$30m a year).
- » Providing 25 graduate nurse scholarships to Very Low Cost Access (VLCA) practices to cover nurses' salaries and graduate support (\$1.5m a year).
- » Develop primary care-based early intervention teams for musculoskeletal pain to assist with pain management and patient education to help prevent surgery (\$6 million over three years).

- » Increase funding for maternity services (LMCs) and health NGOs (extra \$20m per year).
- » Review the Population Based Funding Formula (PBFF).

- » Apply intensive case management to those beneficiaries who struggle to budget and pay for the basics.

NZ FIRST

- » Raise minimum wage to \$17.
- unemployed people taken on for trade training and skills
- » Ensure that benefits (and abatement levels) are inflation

LABOUR

- » Increase the minimum wage to \$15 an hour in first hundred days and to \$16.25 an hour in early 2015.
- » Comprehensive Youth Employment Package aiming for all people under 20 to be in work, education or training, (\$183M).
